- Discussion of pool issues that need to be addressed. Pool house is in need of repairs as well as bathrooms. New pool furniture was purchased last year.
- As of now the pool will open on time this year on Memorial Day weekend. There will not be a pool opening party if restrictions for gatherings are still in place.
- Financials were reviewed by Howard Rinne as well as the 2021 budget. (see below)

- Discussion of considering storage Shed/Cabinets being allowed if installed against resident's house. Board is discussing how that might work and the limitations.
 - Discuss options should we amend the architectural rules.
 - Should be attached to the house.
 - Has to be pre-approved by the Board
 - Will have size-restriction and up against the house.
 - Let the entire HOA vote on yes or no on sheds with specifications and restrictions?
 - Requires preapproval before purchase and installation.
 - Eric will draft the document for voting on the shed.
 - He will distribute to the Board and double-check the bylaws to see if we can indeed put this to a full HOA vote.
